In Essential Drug List- 2018 Book, the strength of Tetanus Vaccine (Adsorbed) Injection is mentioned as 0.5 ml. It is available in pack size of 0.5ml single dose Ampoule as well as in 5ml multiple dose vial. The 5ml multiple dose vial is meant for administration to 10 patients which is quite cheaper than 0.5 ml single dose ampoule. Hence, it is recommended for procurement of 5 ml of multidose vials of Tetanus Vaccine with consent from State Health Society.
