1	M/s ADHISH INDUST RIES	<p>In the technical ability criteria there is a condition (on point no.13) that the annual turnover of the company should be 25 Crores for Drug item and 5 Crores for non Drug items. Halazone comes under drug items and it is not really possible for SSI units like us who manufacture only water purification tablets to achieve this turnover as.</p> <p>1. There are not many buyers for this items.</p> <p>2. It is quite a cheap item and its usage is seasonally i.e. only in rainy season and hence cannot be manufactured in bulk and cannot be stored. 	<p>Adhish Industries have been manufacturing and supplying water purification tablets like sodium Dichloroisocyanurate (Nadcc) Chlorine Tablets and Halazone Tablets in different strengths since the last 30 years to various government and private institutions. It is our experience that Halazone Tablets USP 4mg are highly unstable and lose their chlorine content very fast hence most manufacturers, except a few, have stopped making them and do not prepare raw material in advance either. When we get confirmed order then only they prepare the raw material. Secondly due to its unstable nature it takes 4 to 5 days to manufacture only about 25 kg of raw material for halazone tablets as against chlorine tablets and Nadcc tablets which are highly stable, economical and effective, hence are made easily in bulk quantity and retain their chlorine content for a longer duration so their shelf life is about 2 years as against halazone which is 9 months only. Moreover halazone tablets USP 4mg is used to treat only 1 to 2 liters of water while chlorine tablets is used to treat 25 liters of water so in this way it is very economical to use also.</p>	<p>Tender has been floated vide NIT S.N. 2 for Tab.
