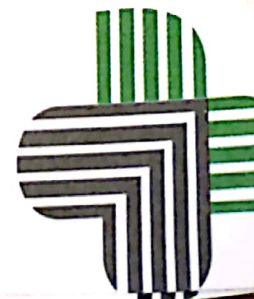

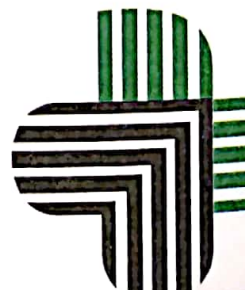

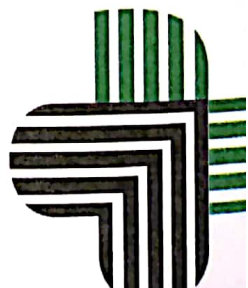

5. The firm M/s Wings Biotech has not submitted the hardcopy. The bid of M/s Concord Biotech Limited has obsoleted by online e-proc system. The Tender clause (3) Note no-(iii) states that, "The technical evaluation shall be done only on the basis of documents/papers submitted by the bidder on [www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in)." Accordingly, it was unanimously decided to recommend for considering only those 11 bidders (from s.no- 1 to 11 of the above-mentioned list) who have successfully submitted their bids online as well as offline, for further technical evaluation process.

6. It was also unanimously decided to recommend to return the hardcopies of received bid of the firm M/s Concord Biotech Limited as the bid is obsolete by online e-proc system.



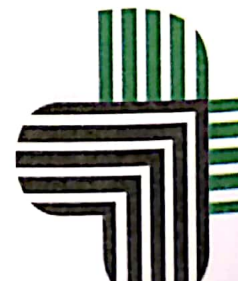

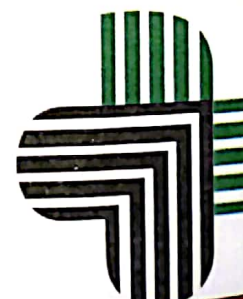
