M/s Revat Laboratories Private Limited, Kurnool Road, Pernamitta, Ongole-523002, Andhra Pradesh was issued a Purchase Order vide Purchase Order No.-BMSIC/40015/28-2018/5284, dated- 01/02/2019 for the supply of 2,45,000 units of Tranexamic Acid Tablet, 500 mg in terms of the Rate Contract executed as per Agreement dated 25/01/2019, but the said firm failed to supply the ordered quantity within the stipulated time.

In view of the above, M/s Revat Laboratories Private Limited was issued Show Cause Notices vide this office letter No.- BMSIC/40015/28-2018/778, dated- 17/05/2019 and letter No.- BMSIC/40015/28-2018/2724, dated-16/08/2019 respectively, seeking explanation within seven (07) days of issue of each notice. In the said notices it was asked to show cause as to why BMSICL should not initiate necessary action against the said firm in accordance with the terms outlined in tender clause 27 (c) contained in bid reference no. BMSIC/DRUGS/18-07.

Clause 27 (c) of the referred bid document states that, "In case, the supplier is found to be habitual defaulter of delayed supply or not supplying the full quantity in time, the balance amount of performance security of such company shall be forfeited. No further supply order shall be given to them and company shall be barred from participating in any tender floated by BMSICL, further other punitive action such as blacklisting of the firm for a minimum period of 2 years from the date of intimation for blacklisting/debarring."

The firm was also given an opportunity of personal hearing on 30/09/2019 before the tender inviting authority at BMSICL, Patna vide this office letter No.-BMSIC/40015/28-2018/3500, dated-17/09/2019. The authorized representative of M/s Revat Laboratories Private Limited appeared before the authority of BMSICL on 30/09/2019 and submitted a written reply stating that their firm M/s Revat Laboratories Private Limited would supply 1,00,000 tablets of Tranexamic Acid 500 mg tablet within next 35 days and would also supply the balance quantity of the P.O. as per the Rate Contract Agreement. In the interest of the patients at various Health Institutions of Govt. of Bihar, the firm was again allowed for supplying the ordered quantity i.e. 2,45,000 units of Tranexamic Acid 500 mg tablet within 30 days i.e. latest by 4th November 2019 vide BMSICL letter no.- BMSIC/40015/28-2018/3964, dated- 04.10.2019.

It is thus explicitly clear that the said firm was allowed a total duration of 277 days for the supply of the said drug, but the firm has failed to supply the said drug till date.
