NO. BMSIC/SANITARY NAPKINS/19-01(RATE CONTRACT AND SUPPLY OF SANITARY
NAPKINS FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR).**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/ SANITARY NAPKINS/ 19-01** was held on **12th November 2020** under the Chairmanship of Dr. Navin Chandra Prasad, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

2. The Details of the invited tender are as follows:

4. The firms i.e., M/s Om Industries, M/s Smart Hygeia., M/s Soothe Healthcare Pvt. Ltd., M/s Anglo Goldy Hygiene Healthcare Pvt. Ltd, M/s Easelife Sanitary Products Private Limited, M/s Om Surgical Industries & M/s Jackson Care Product neither submitted the hardcopy nor considered by the online e-proc system.

5. The firm M/s Fibriltex Private Limited submitted the Hard Copy of Bid Document but Tender Fee and EMD was not enclosed and the said firm not considered by the online e-proc system.

6. The firms M/s Soft Medicaps Ltd. and M/s Johnson and Johnson Private Limited had not submitted the Sample. Only the firms M/s Zenith Infratech, M/s Nandani Marketings Private Limited, M/s HLL Lifecare Limited, M/s Shree Chitranjan Meditech & Co, M/s Sekhani Industries Private Limited, M/s Shree Radhe Hygiene Products Private Limited, M/s Susheel Yarns Private Limited & M/s Vaidya V & I Infrastructure Pvt. Ltd. successfully submitted their bids online as well as offline and submitted the sample. Hence it was unanimously decided by the Technical Committee in its meeting dated 26.06.2020 to evaluate the bids of the above sample submitting firms only.

7. The said tender was floated on 31.12.2019. In view of lockdown prevailing throughout the country and shut down of different locations in many states due to Novel Corona Virus (COVID-19) outbreak the tender schedule has been extended several times through Corrigendums. According to the requirement, many bidders had submitted hard copy of the tender documents along with the tender fee and EMD well ahead of this tender opening date i.e., 26.06.2020. As per Tender Clause 8(a) the period of validity of the tender is 180 days from the date of opening of technical bid. It was observed that the validity of the received Tender fee (in the form of Demand Draft) and Earnest Money Deposit (in the form of Demand Draft/ Bank Guarantee) has been expired or near to expiry. Hence it was recommended to ask the bidders for extension of the validity of the provided Tender fee and Earnest Money Deposit within a time limit of 10 days after releasing the official communication. The bidders who do not extend the validity of the provided tender fee and Earnest Money Deposit within the stipulated time period, shall have no right to claim in future as their bids shall become non-responsive due to lack of valid tender fee and EMD. Accordingly, all the bidders have submitted the revalidated Tender fee and Earnest Money Deposit.

8. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 5902 dated 22.10.2020.

9. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the firm wise technical evaluation findings by TEC in today's meeting has been recorded as follows:

As per the above comparative chart Six bidders namely, M/s Nandani Marketings Private Limited, M/s HLL Lifecare Limited, M/s Sekhani Industries Private Limited, M/s Shree Radhe Hygiene Products Private Limited, M/s Susheel Yarns Private Limited & M/s Vaidya V & I Infrastructure Pvt. Ltd. were found technically qualified. Hence it was unanimously recommended to carry out the physical verification of manufacturing unit of all the above mentioned technically qualified firms.
