The Tender clause (3) Note no-(iii) states that, "The technical evaluation shall be done only on the basis of documents/papers submitted by the bidder on www.eproc.bihar.gov.in." Accordingly, it was unanimously decided by the Technical bid opening committee in its meeting dated 18.11.2019 to recommend for considering only those 7 bidders (from s.no-1 to 7 of the above-mentioned list) those were successfully submitted their bids online as well as offline, for further technical evaluation process.

8. It had also been observed by the Technical bid opening Committee in its meeting dated 18.11.2019 to return the hardcopies of received bids for both the firm i.e., M/s Bharat Parenterals Limited & M/s Modern Laboratories Ltd.
