
**Pre-Bid Meeting:-**

2. Gautam Agrawal DGM (Drugs) BMSICL, Patna.



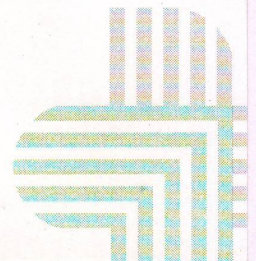
