1. Bihar Medical Services & Infrastructure Corporation Limited (BMSICL) intends to **Empanelment of contracting agencies for repair and maintenance of assets owned by Health Department Entities, Govt. of Bihar.**
2. BMSICL invites bids in this regard from interested Contracting Agencies. Detailed terms and conditions may be viewed on the website <https://eproc2.bihar.gov.in>. The empanelment of contractor is proposed in different categories based on, among other things, their experience, capabilities etc.
3. **Scope of Work:** The Scope of work under this includes maintenance and repairs to newly or previously constructed buildings or structures, including remodelling or replacement. "Repair works" means works undertaken to maintain building and fixtures. Expenditure on Repair Work does not add to the value of the asset and only restores the functionality of the asset. Repair Work can be further categorized as (i) Annual repairs covering routine and yearly operation and maintenance work on buildings and services (ii) Special repairs, which are undertaken as and when required, covering major repairs to existing buildings or services for following categories:-
