- (2) The tender should be submitted through Gem portal only. No other form of tender submission will be valid for evaluation.
- (3) The required amount of earnest money is acceptable either in the form of Bank Draft or Bank Guarantee in proper format issued by any Nationalized/Schedule Bank issued in favour of **M.D. Bihar Medical Services and Infrastructure Corporation Limited, Payable at Patna**. *The original earnest money will have to be deposited along with the hard copy of Tender Document in the office of as per tender schedule, failing which Tender will be rejected. The earnest money deposited in any other form shall not be acceptable.*
- (4) The firms registered under MSME are exempted from submitting EMD. No other exemption will be allowed under this category.
