Bihar Medical Services & Infrastructure Corporation Ltd., Patna had invited tender through Notice Inviting Tender No- BMSICL/Infra/31/2023 Dated- 09.10.2023 for Selection of Authority Engineer for Redevelopment of Patna Medical College and Hospital (PMCH), Patna. For the publication of the said tender, a request was made to Director, Information and Public Relation Department, Patna, Bihar vide this office's letter no.- BMSIC/75030/01-2023/5776 Dated-09.10.2023 to publish the tender notice in various major daily Newspaper of all over India. As a result, the said tender notice was published by the Information and Public Relation Department in Hindustan Times and other Newspaper on Date-12.11.2023, whose advertisement Number is PR- 10077 (Ni Ni) 2023-24. For wide publicity of the tender, the said tender was also published on the corporation's website [www.bmsicl.gov.in](http://www.bmsicl.gov.in) and <https://eproc2.bihar.gov.in>.



3. After the tender invitation, the tender received from various consultant were opened on 10.11.2023 at 15:30 Hrs in the BMSICL office in the presence of participating bidders who wished to witness the bid opening process.
4. It was observed that in total 03 bids were received which were taken up for Evaluation. The Tender Committee there upon scrutinized the bids received based on the **minimum eligibility criteria** as specified in the tender document and the evaluation details pertaining to eligibility criteria is as per the following:
